² Special Resolution

The Board of Trustees have carried out a full review of DWT's Articles of Association working closely with DWT's legal advisors.

The current articles date back to 2012 and so have become outdated in a number of important respects and it is therefore proposed to adopt completely updated articles to replace the current articles. The revised articles proposed to be adopted reflect the Trustees' wish to ensure DWT has the benefit of a fully updated governing document reflecting latest company and charity law and governance best practice. Members can be reassured that no changes are being proposed around their voting rights, or to DWT's overall governance structure or in relation to the overarching charitable objects of DWT.

A copy of the revised articles of association proposed to be adopted are enclosed with this Notice, if you receive printed papers by post and can be viewed on the AGM page of DWT's website, if you have opted to receive documents and information electronically.

The main changes to the current articles contained in the proposed new articles are to:

- Introduce a maximum number of Trustees of 15 (there is currently no maximum). See Article 4.3.
- Introduce fixed three-year terms of office (renewable) for Trustees to replace the current rotational retirement provisions, in the interests of clarity and administrative simplicity. See Article 4.6.
- Retain nomination of a potential Trustee by a member but add the ability for the Trustees to set an earlier deadline by which nominations must be received (this to allow for a fair and robust process of scrutiny and selection of nominees, including by the nominations committee and DWT Board). See Article 4.7.
- Set a maximum of two terms of office of three years for Trustees with the ability to extend, in increments of one year, by up to three years by exception, to promote a progressive refreshing of the Board of Trustees. See Articles 4.9. and 4.10.
- Introduce a new provision allowing the DWT Board to remove a Trustee in the case of misconduct or where the Board otherwise reasonably believes that their removal as a Trustee is in the best interests of DWT, following a fair process. See Article 4.12(h).
- Clarify that DWT has individual members only, not organisations or companies (a separate 'supporter framework' provides for the latter). See Article 12.

All Charity Commission consents to the proposed new articles have been obtained to the extent required.

The Board of Trustees strongly recommend that the membership approve the proposed revised Articles of Association.

Proxy voting

A member entitled to attend and vote at this meeting is entitled to appoint one or more proxies to attend and vote in their stead. A proxy need not be a member of the Company. Forms of proxy can be obtained from the Governance Officer. A signed form of proxy must be received by DWT no later than 2.00pm on Wednesday 19 November.
